Event Cancellation or Postponement

IAVM reserves the right to cancel or postpone an event due to low participation, severe weather, or any other circumstance which would make the event non-viable. If IAVM cancels an event, registrants are eligible for a full refund. If an event is postponed or rescheduled, registrants will receive a full refund. IAVM is not responsible for travel arrangements or any other actual or perceived loss due to cancellation or postponement of an event.

Registration

Member rates apply to individuals with current membership status at the time of registration.

Payment

All payments must be submitted in U.S. funds. International wire transfers incur a USD \$25 fee.

Cancellations and Refunds

Cancellation and refund requests must be made via email to the IAVM Meetings Department at <u>meetings@iavm.org</u>. Fees are calculated based on the full cost of registration and the date cancellation request is submitted.

If a registrant is unable to attend an event for any reason, someone else from their venue/company may attend in their place with written notice up to 2 weeks prior to the event start date. If a cancellation is necessary, the following refund deadlines apply:

- Cancellation request submitted on or before May 19, 2023: FULL refund
- Cancellation request submitted between May 20 July 21, 2023: 25% refund
- Cancellation request submitted on July 22, 2023 or later: No refund
- Optional fees (including, but not limited to: golf and pre-conference workshops) are non-refundable from the time of purchase.

The above cancellation deadlines apply to PAID, UNPAID, and partially paid registrations. Invoiced no-shows will be billed as a cancellation accordingly. Late requests for refunds due to special circumstances will be considered on a case-by-case basis.

Rollover Policy

There is no rollover option. If a registrant is unable to attend, and the venue is not able to send another attendee, registration will be refunded based on the above cancellation deadlines.

- Inappropriate use of nudity and/or sexual images in presentations or comments.
- Threatening or stalking of any meeting participant.
- Postings of any promotional materials, special offers, job offers, product announcements, or solicitation for services. IAVM reserves the right to remove such messages and potentially ban sources of those solicitations.
- Real or implied threat of professional or financial damage or harm.
- Inappropriate disruption of meetings or presentations.

Unacceptable behavior will not be tolerated and will have consequences. Anyone asked to stop unacceptable behavior is expected to comply immediately. If a participant engages in unacceptable behavior, IAVM may take any action they deem appropriate, up to and including expulsion from the event without warning or refund and, if appropriate, involvement of local law enforcement. Breaches of this Code of Conduct can result in disqualification from participating in future events and termination of IAVM membership.
