

IAVM 2025 Super Regional Meeting * May 19 - 21, 2025 in Raleigh, NC

Three scholarships are being offered to members of Region 5 (R5) only that will cover the cost of Registration (member rate of \$320.00) and provide a \$500.00 stipend towards lodging and travel expenses. **All other expenses are to be incurred by the applicant/employer.** Visit <https://iavm.org/events/> for more information.

Eligibility: Scholarship applications will be selected according to the following priority order of criteria:

1. IAVM member working at a venue (workplace) located in Region 5 (VA, TN, NC, SC, MS, AL, GA, FL, LA, Central & S. America).
2. IAVM non-member working at a venue (workplace) located in R5 with a co-worker at the venue who is a member of R5.
3. IAVM member who resides in R5 but is not working at a venue whose management are eligible for IAVM membership.

The selected applicant must register for the meeting no later than March 21, 2025. Scholarship recipients must be an active resident in a Region 5 state during the application process and during the meeting for which the scholarship is being offered.
